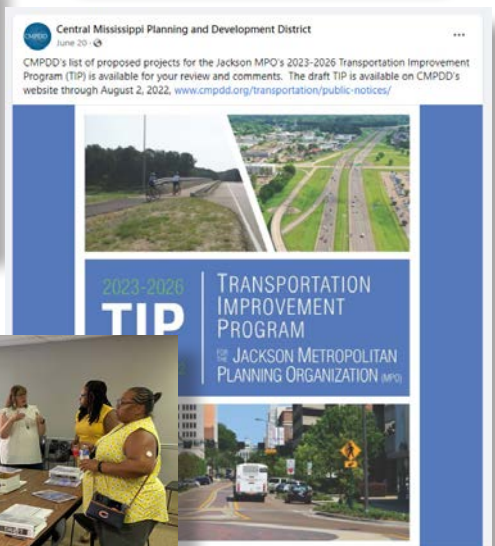




MPO Public Engagement Evaluation Fiscal Year 2022

October 1, 2021 – September 30, 2022

Annually the Jackson Metropolitan Planning Organization (MPO) evaluates its public engagement activities to determine if changes are needed to the MPO's public participation activities. Formally called the Public Participation Plan (PPP), the PPP outlines a proactive public involvement process for the MPO's transportation planning initiatives. Public participation is not only an essential piece guiding MPO decisions but is required to ensure the MPO meets federal guidelines. This evaluation provides an overview of the participation activities the MPO implemented over the past fiscal year (October 1, 2021 thru September 30, 2022).



MPO Documents Published or Adopted

Each year the MPO produces a variety of plans, projects and studies. The resulting documents are made available to the public as reports and maps. Based on the type of document, feedback is solicited through a variety of formats including but not limited to community meetings, presentations to the MPO committees, social media, or online engagement. Overall, there were 6 plans, reports, and studies produced in Fiscal Year 2022.

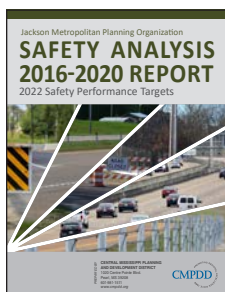
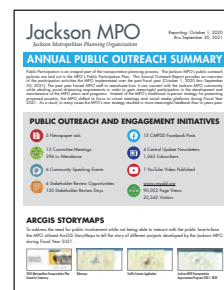


FY 2021 Obligated Projects Report

Provides a synopsis of the MPO's outreach activities from October 1, 2020 thru September 30, 2021. Published December 2021

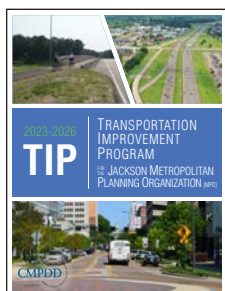
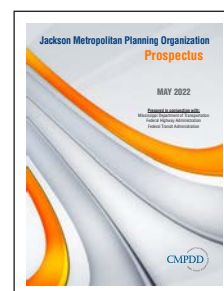


2016-2020 Safety Analysis Report

Produced annually as a way to track the progress being made to reduce crashes in the MPO planning area. The report primarily focuses on the number and types of crashes that have occurred and the resulting injuries or fatalities. The report also details the MPO's annual Safety Performance Targets. Published May 2022

Bylaws document that outlines the MPO's organizational structure and responsibilities. Adopted May 2022

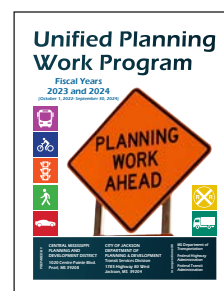


2023-2026 Transportation Improvement Program

A short-term planning document listing approximately four years of federally funded or regionally significant transportation projects. Adopted August 2022

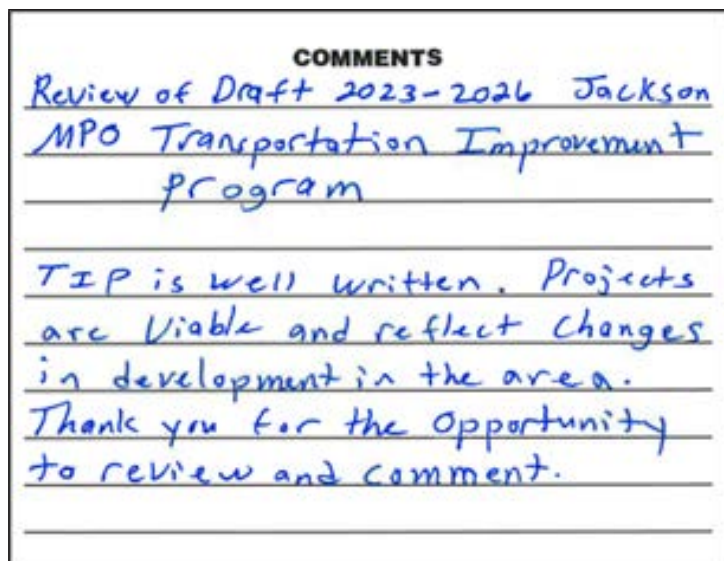
2023-2024 Unified Planning Work Program

Describes how the MPO and the regional public transit provider will spend federal transportation planning funds over each fiscal year. Adopted August 2022

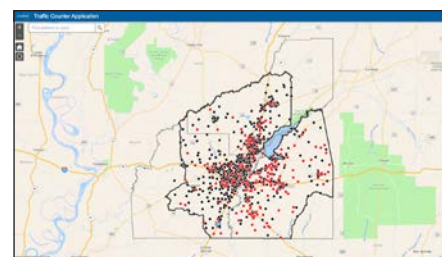
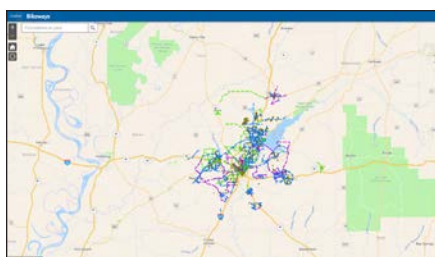
