

**NOTICE OF PROPOSED
AMENDMENTS TO THE 2035 JACKSON URBANIZED
AREA TRANSPORTATION PLAN**

The Central Mississippi Planning & Development District (CMPDD) is the Metropolitan Planning Organization (MPO) responsible - together with the Mississippi Department of Transportation (MDOT) and operators of public transit in the area (JATLAN) - for coordinating a Federally-mandated Transportation Planning Process for the Jackson Metropolitan Area (Hinds, Madison and Rankin counties). One of the responsibilities of CMPDD, as the MPO, is to prepare a Long Range Transportation Plan (LRTP) that addresses future transportation needs for the Jackson Urbanized Area over a 25 year planning horizon. This plan is made up of five (5) separate volumes that make up the overall plan. These volumes include a Streets and Highways Plan, Regional Transit Plan, Bicycle and Pedestrian Facilities Plan, Congestion Management Process and Transportation Safety, Security and Environmental Mitigation Analysis.

CMPDD is holding a 10-day public comment period beginning April 25, 2014, for a proposed amendment to the 2035 Jackson Urbanized Area Transportation Plan. This process is being conducted in accordance with CMPDD's adopted Public Participation Plan and Federal and State regulations. Detailed information regarding these amendments to the Long Range Transportation Plan is available online at www.cmpdd.org. We invite you to provide feedback through the Transportation Comments Form located under the Transportation Planning tab online. The Intermodal Technical Committee will consider the proposed Long Range Transportation Plan amendments following the end of the comment period on May 7, 2014. Your views concerning the proposed amendments will be appreciated.

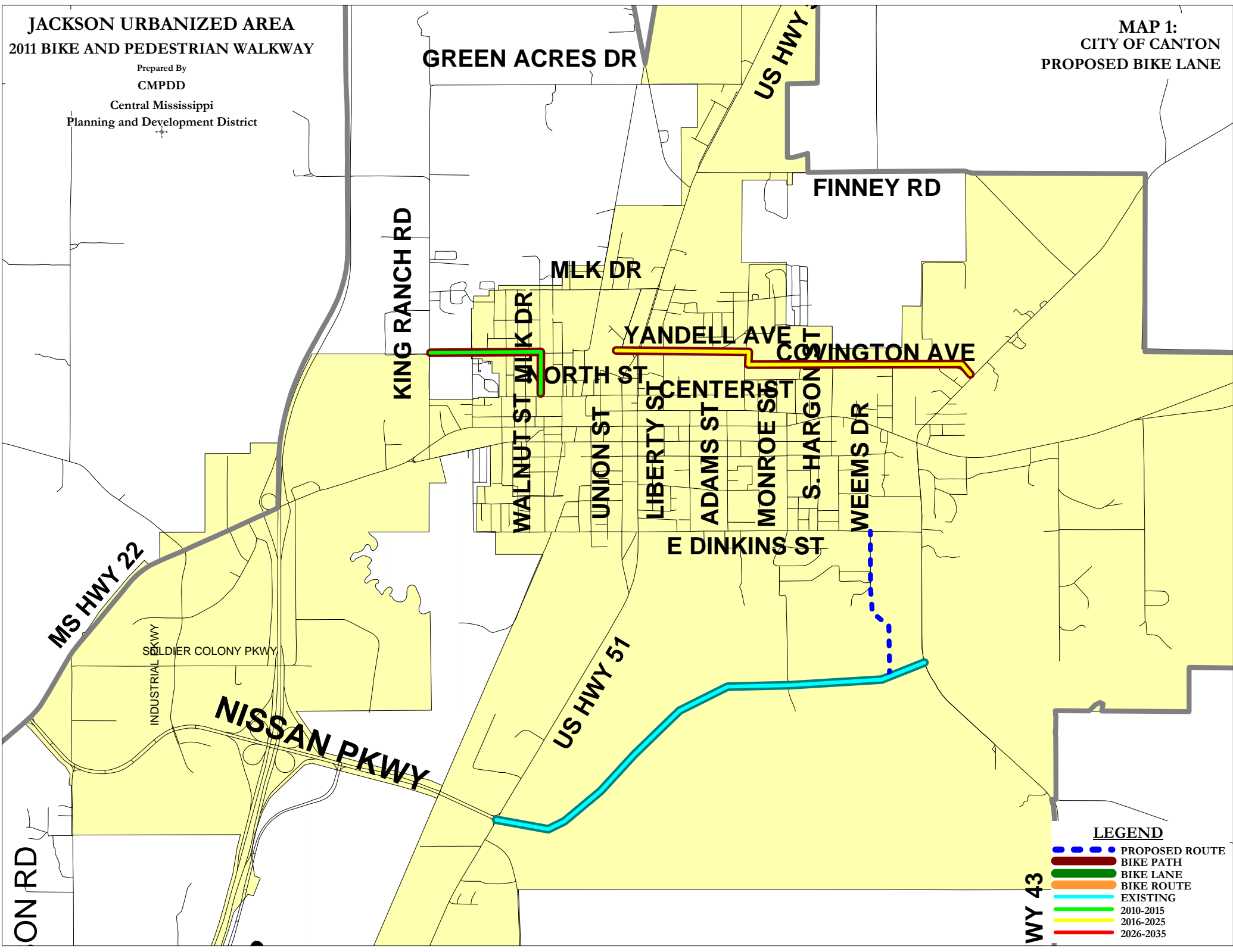
