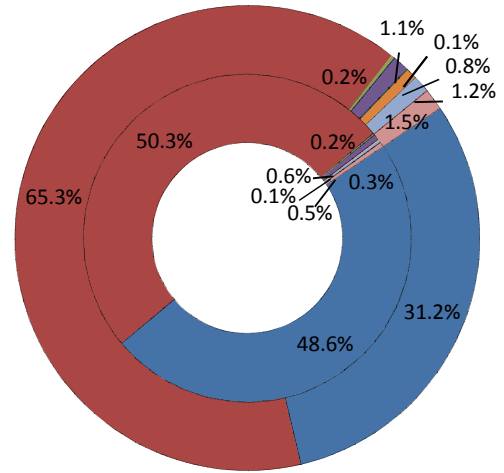

### Housing Units by Race of Householder



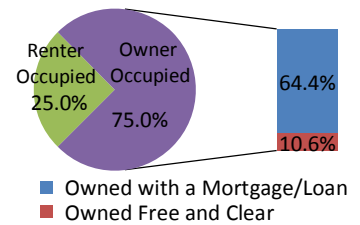

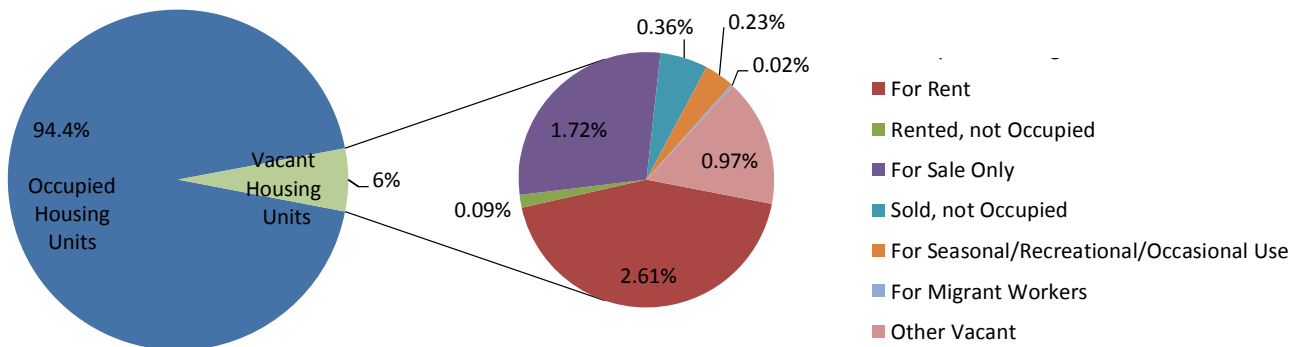

### Total Housing Units by Occupancy



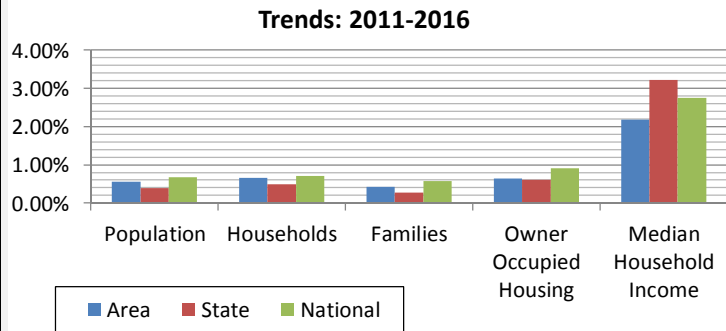
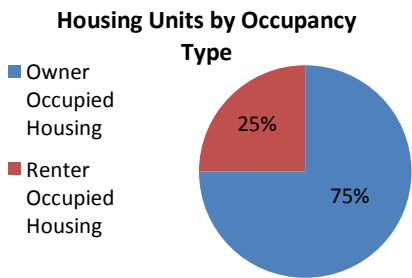

**Population by Age**



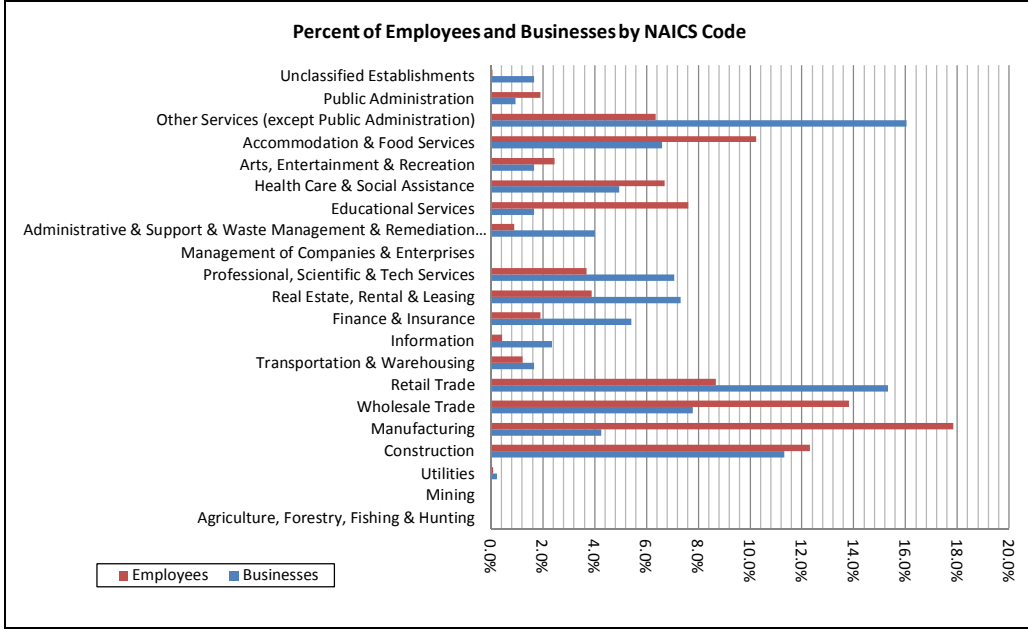

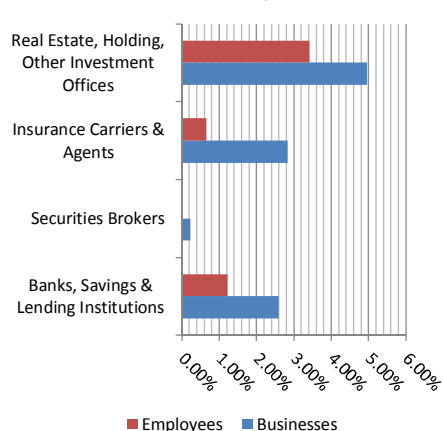
