

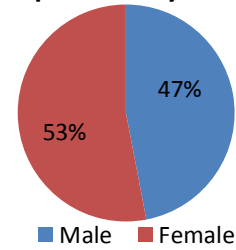

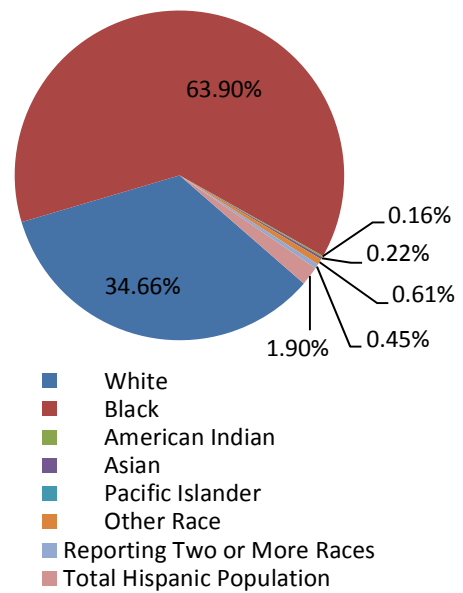

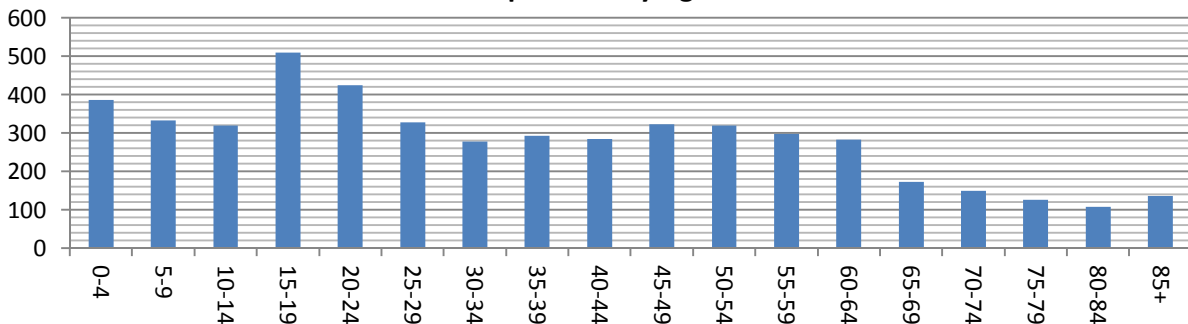

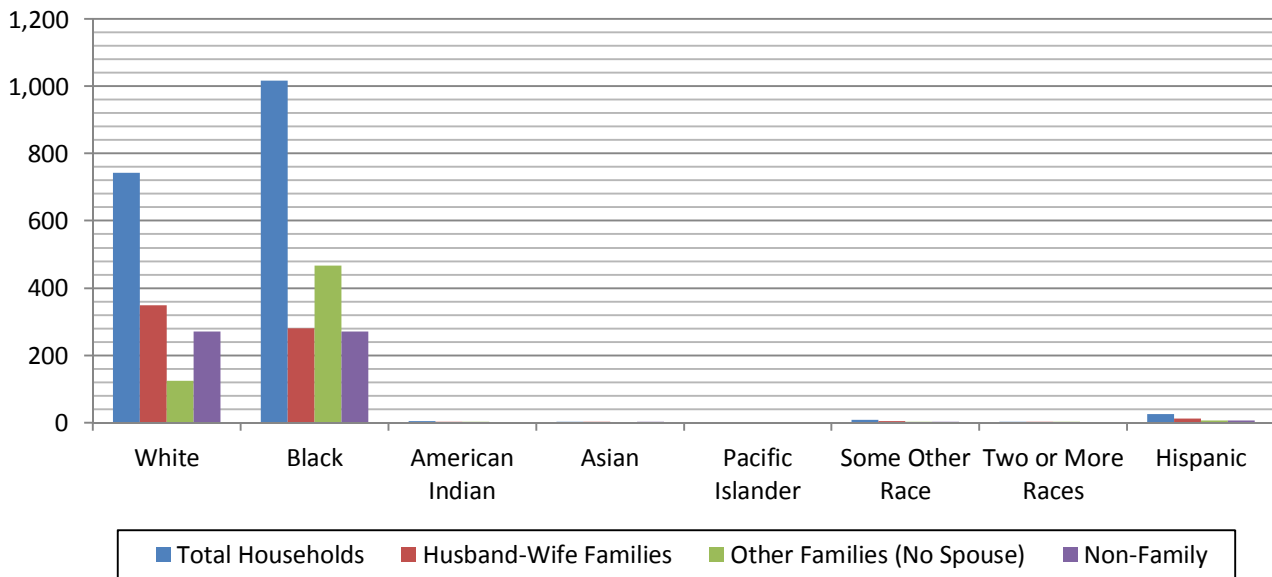

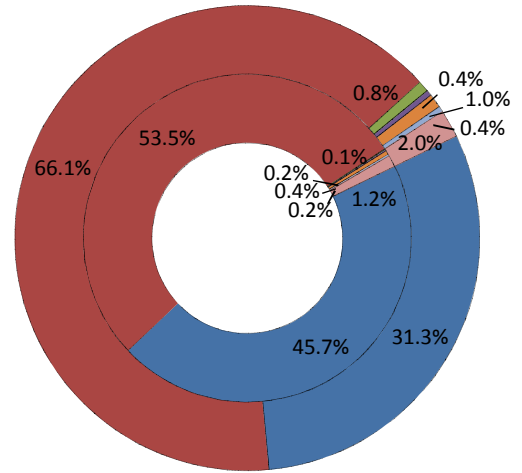

Housing Units by Race of Householder



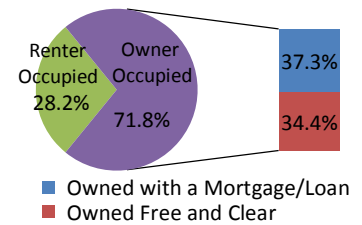

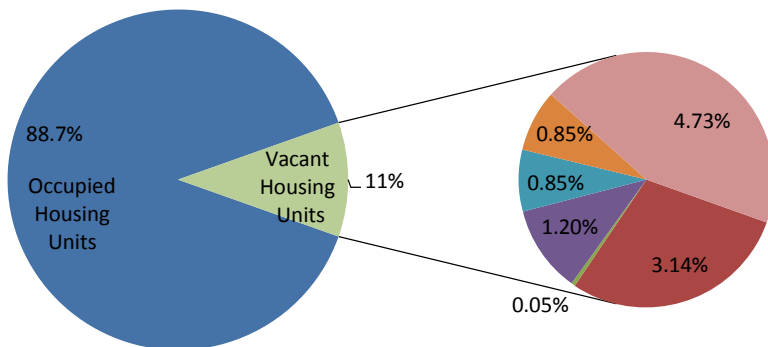

Race and Ethnicity



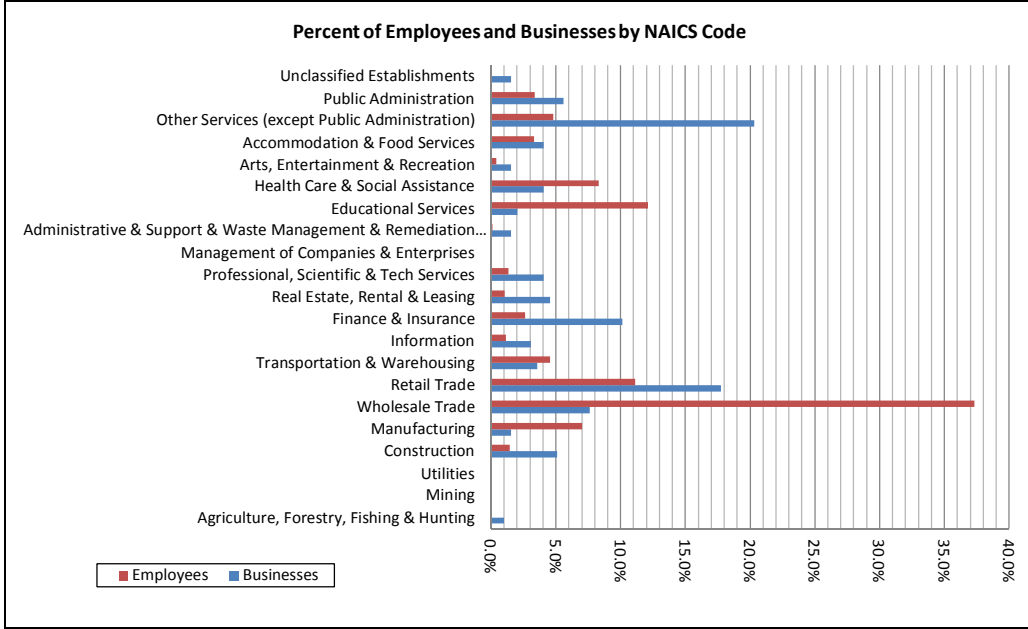
