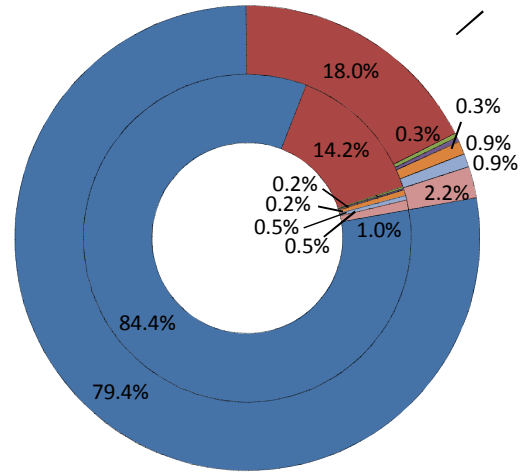

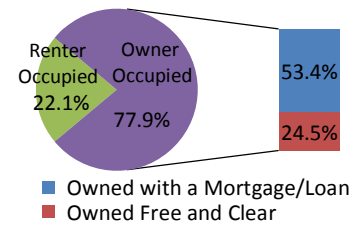

Race and Ethnicity



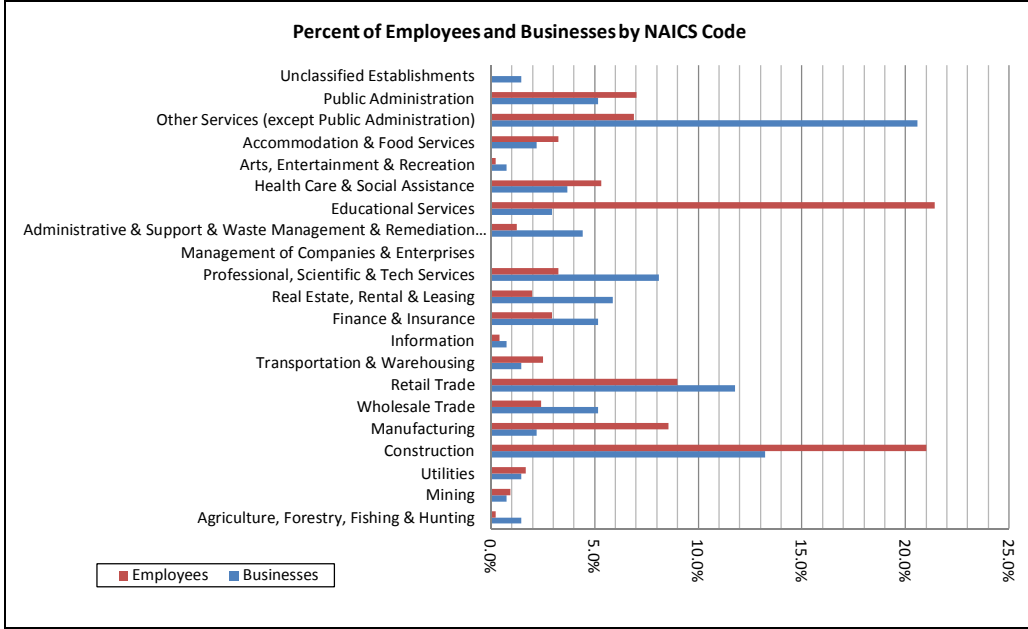
Population by Age

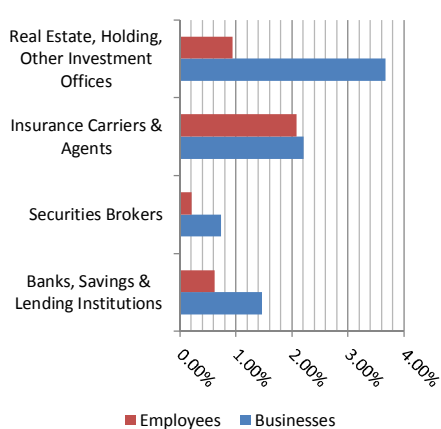
