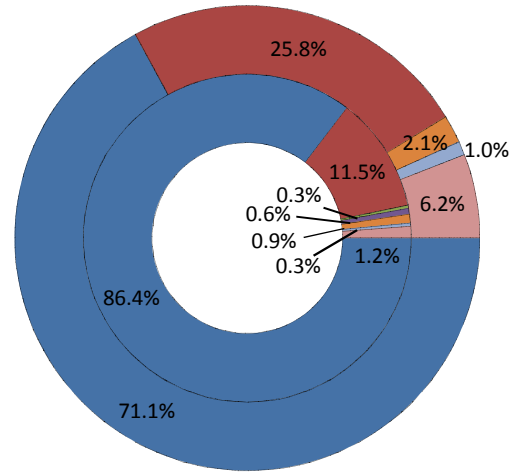

Housing Units by Race of Householder



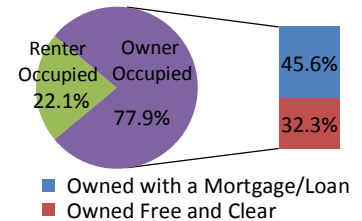

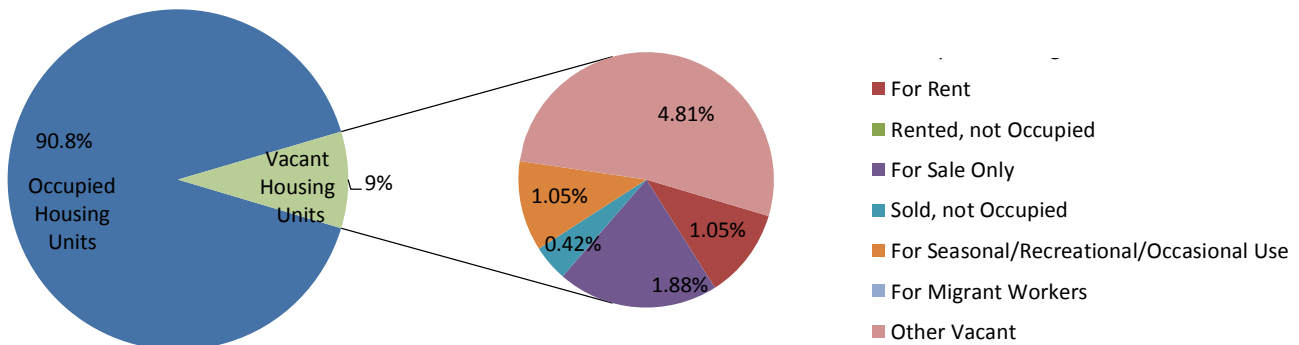

Total Housing Units by Occupancy



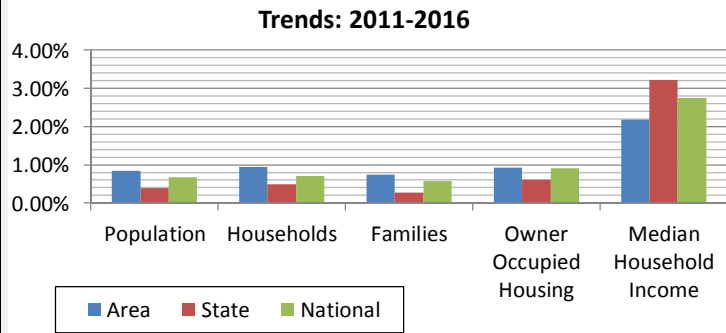
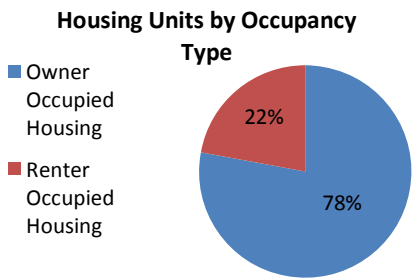

Population by Age



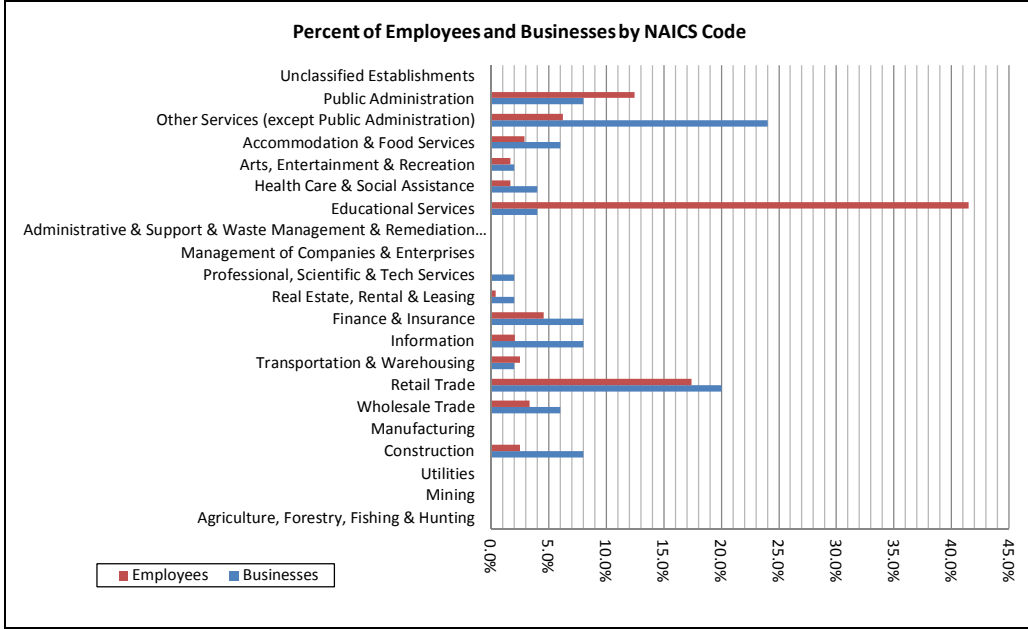

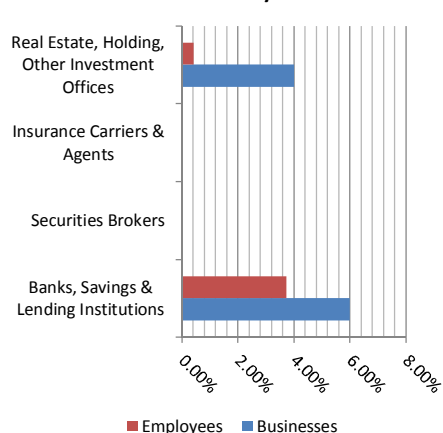
