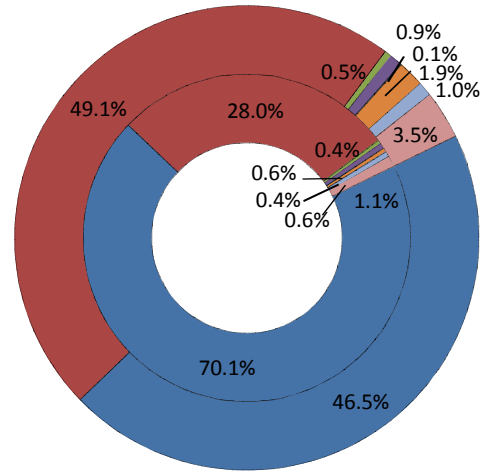

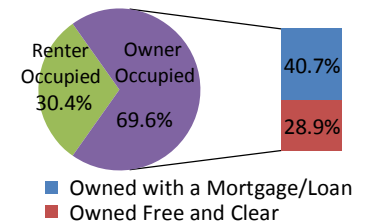

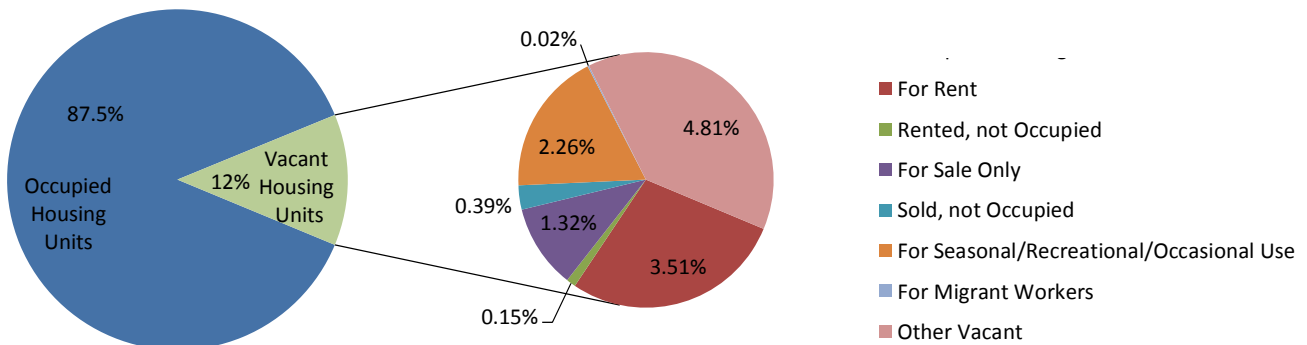

Population by Age



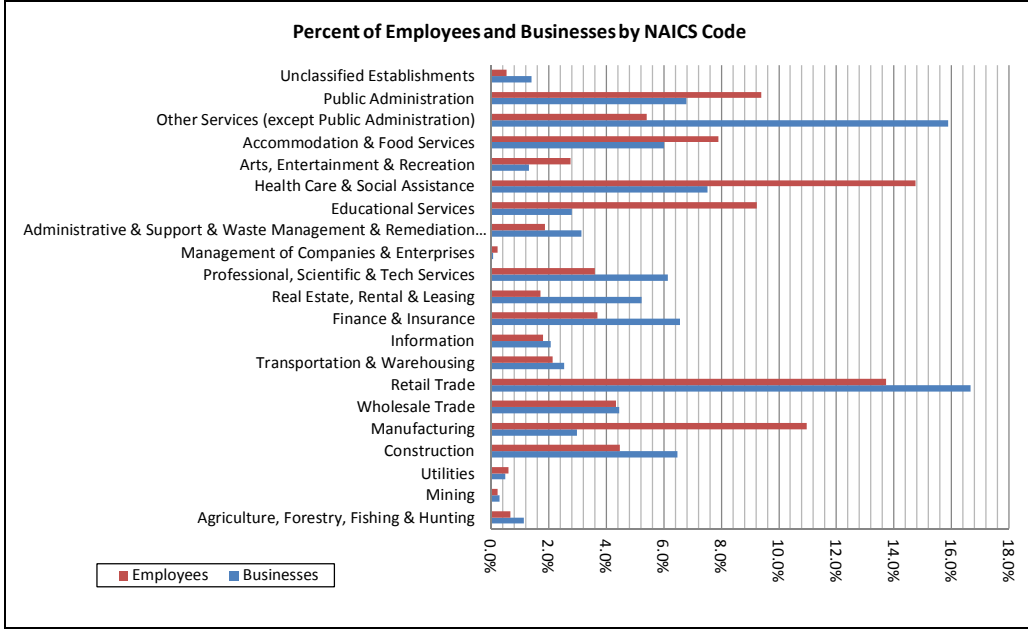

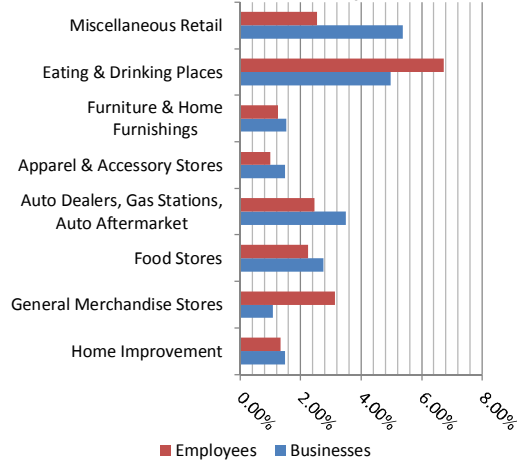
